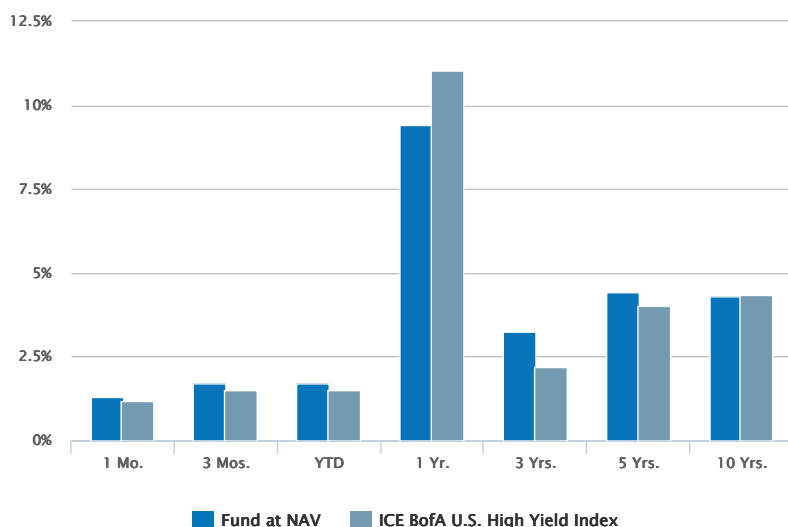

Maturity Distribution (%)⁴

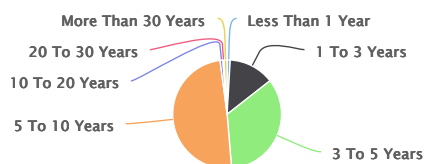
