## The Features

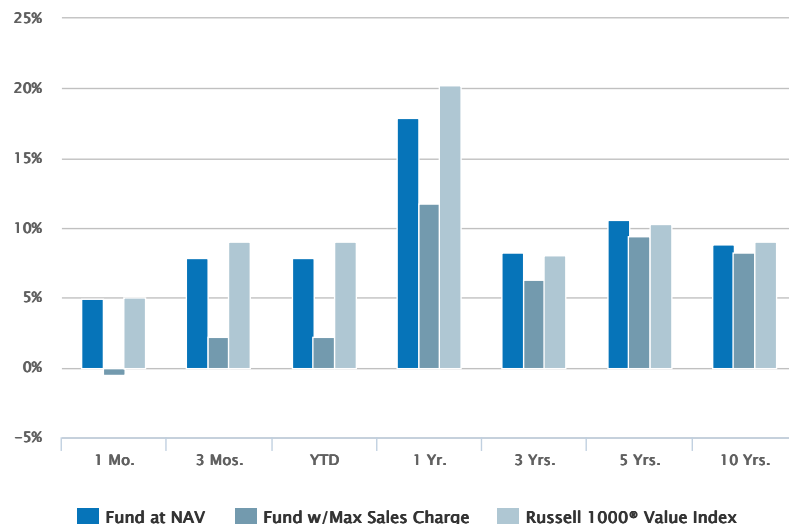

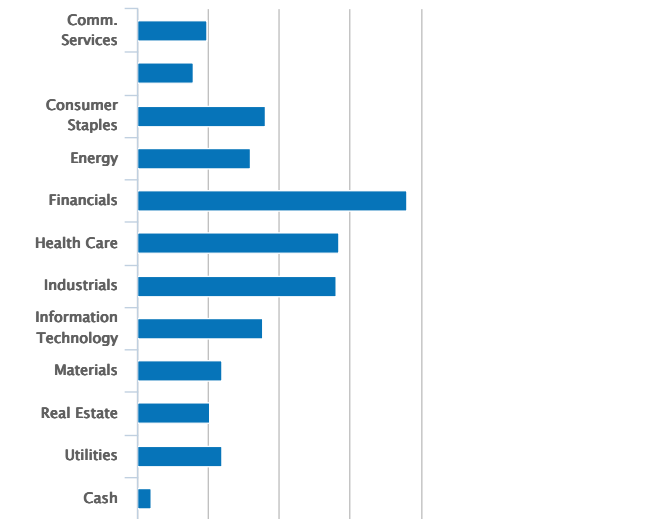
