## The Features

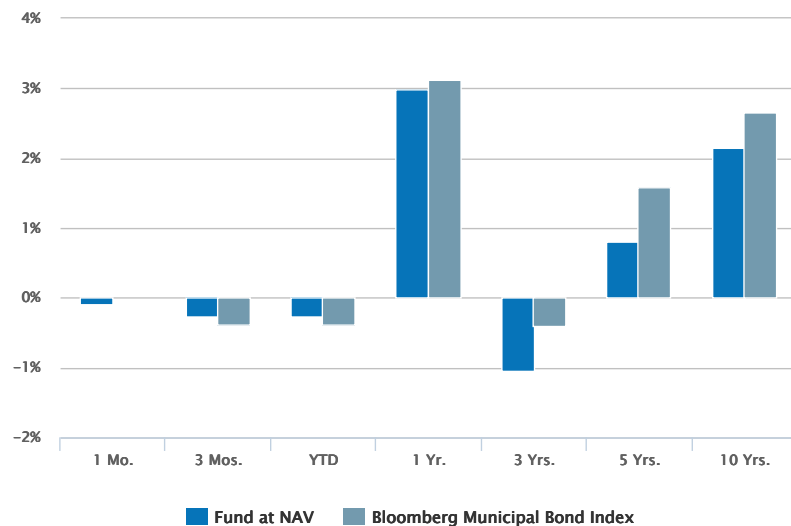

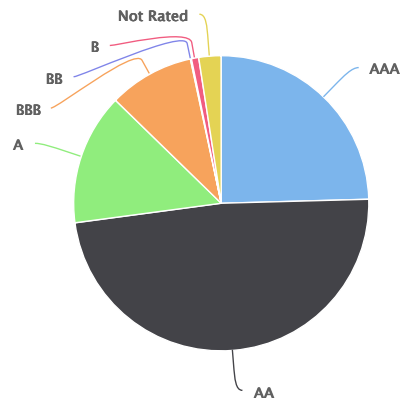

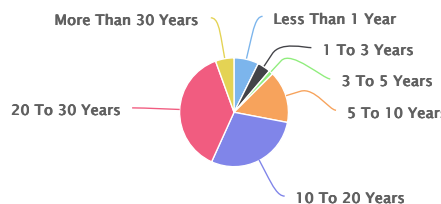
