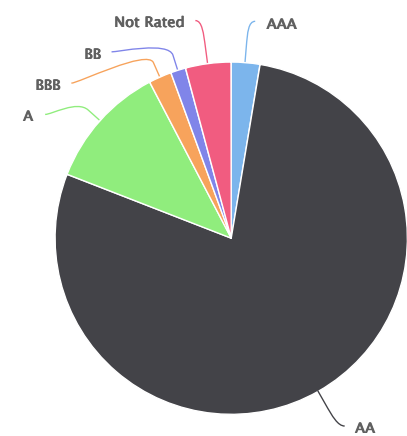

Maturity Distribution (%)¹¹

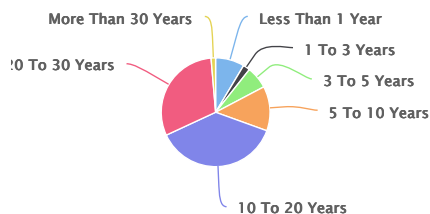
