#### The Fund

The Approach

The Fund provides exposure to the shorter duration segment of the high-yield bond market, investing primarily in investments with an expected duration profile of three years or less. Managed for total return, the Fund seeks a combination of both current income and capital appreciation potential. Managed by Eaton Vance, one of America's most experienced high-yield bond managers. Fundamental bottom-up credit research and top-down market analysis are the cornerstones of the Fund's approach. Invests broadly across the shorter duration high-yield bond universe, providing exposure to the high-yield market's many sectors, credit tiers and issuers. A focus on research and lower duration may help provide lower overall risk than other high-yield bond strategies.


#### The Features

The Fund's investments in shorter duration high-yield bonds and floating-rate loans may help provide investor portfolios' a level of protection in a rising-rate environment, as investments in the Fund's universe have typically performed with low correlation to traditional bond markets. 




