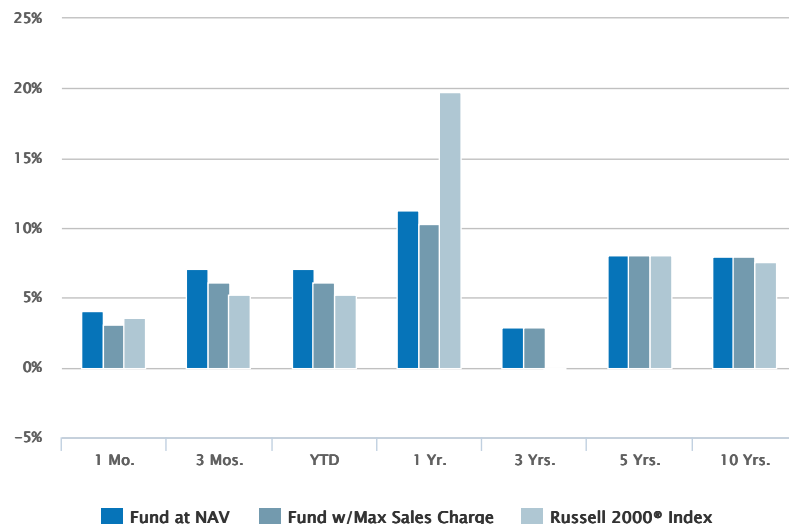

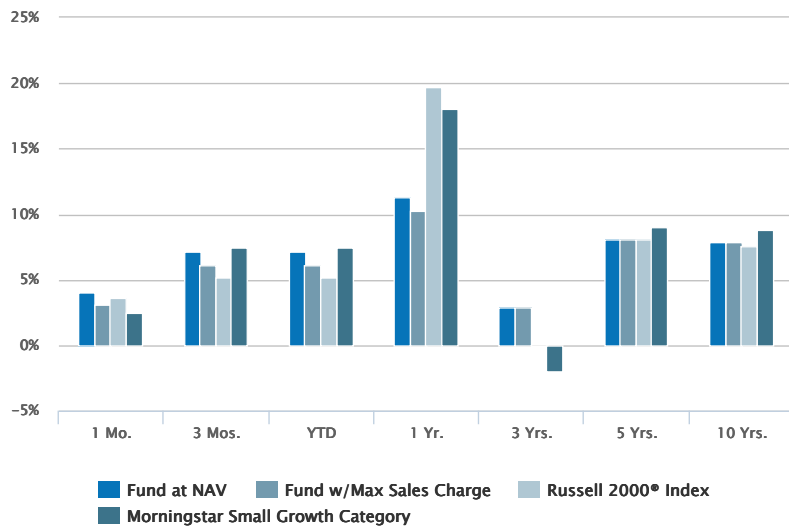

Asset Mix (%)^{5,9}

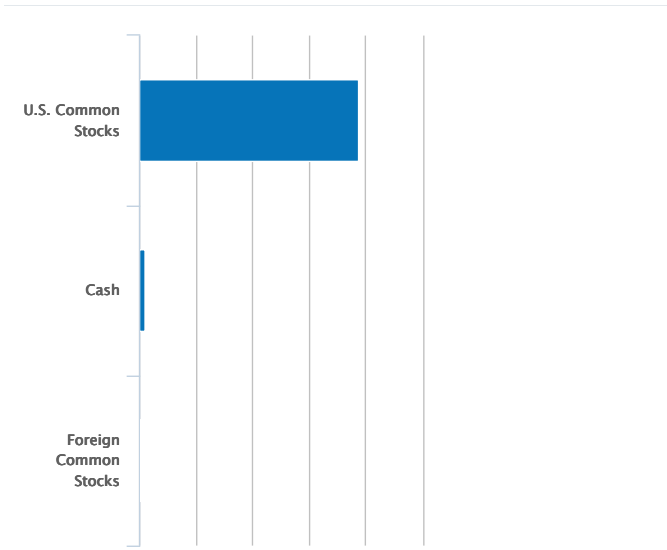

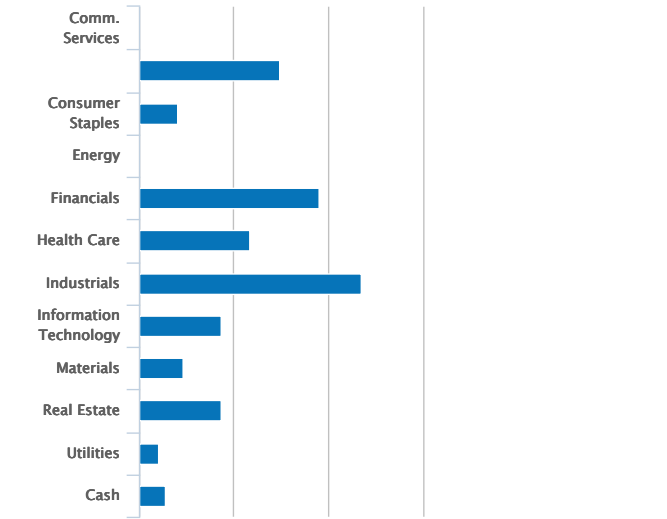
