Washington - The COVID-19 pandemic is exposing inherent weaknesses and vulnerabilities across industries, and the meatpacking industry has been particularly hard hit. Worker safety has been a major challenge for decades, dating back to Sinclair Lewis' "The Jungle," but the pandemic has greatly exacerbated present-day risks for workers. Multiple outbreaks of COVID-19 have occurred among meat and poultry processing facility workers, and particular working conditions add to the risk of the virus spreading. Workers often are unable to maintain the recommended six feet of distance on the processing floor, have prolonged close contact with co-workers during what can be 10-12 hour shifts and risk exposure to the virus through respiratory droplets in the air.¹
