The management team seeks to invest in high quality, low-volatility alternatives to low-yielding money market and government debentures. We target ultra-short securities that we believe to be of the highest quality with low credit and event risk. The team seeks to protect principal and generate a consistent source of income and liquidity. Traditional short-term, low volatility mortgage- and asset-backed securities are emphasized because of their historical substantial yield premium versus Treasury and agency notes.



EMPHASIS ON SECURITIZED SECTORS Sector Allocation (%)



STANDARD DEVIATION (%)



Rather, it is calculated by the investment adviser by determining the average credit quality of the Strategy's investments (including cash held in government money market funds) based on their market value. If individual securities within the portfolio are rated differently by the independent credit agencies, the higher rating is used to calculate the average portfolio credit quality. Unrated securities are included based on internally assigned ratings. Average credit quality may change over time.

Ratings are based on Moody's, S&P or Fitch, as applicable. Credit ratings are based largely on the rating agency's investment analysis at the time of rating and the rating assigned to any particular security is not necessarily a relection of the issuer's current ?nancial condition. The rating assigned to a security by a rating agency does not necessarily relect its assessment of the volatility of a security's market value or of the liquidity of an investment in the security. If securities are rated di?erently by the rating agencies, the higher rating is applied. Ratings of BBB or higher by Standard and Poor's or Fitch (Baa or higher by Moody's) are considered to be investment grade
