Biography



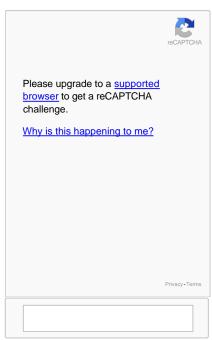
